

Admissions & Student Visas

Australia is home to a growing community of international students because of its stable economic, political and social landscape.

With over 40 Universities and approximately 1515 CRICOS registered institutions, Australia is a recognised provider of qualifications that are accepted across the globe.

We take great pride in assisting our clients with the enrolment into the education provider of their choice. We work with a significant number of education partners across Australia, and our in-house Counsellors are well-versed to provide comprehensive study advice and options to our clients.

Working closely with our overseas offices, we provide an extensive pre-departure orientation program to ensure that our clients (and their families) are mentally and physically prepared for the transition.

Graduate Visas

Many of our clients are keen to remain in Australia (either temporarily or permanently) at the end of their studies. Transitioning to a Temporary Graduate Visa (subclass 485) is often a natural progression.

The application process:

While the application is relatively straightforward, the challenge lies in the tight time frame in which it operates. Given the six-month window for the visa application to take place after the completion of studies, we will often conduct a preliminary assessment prior to the client's completion and start the collection of documents. This ensures that the visa application is ready for lodgment at the end of their studies.

What we do differently:

A Graduate Visa often serves as a pathway towards permanent residency for our clients. As a full-service agency, we're able to identify study options which may increase a client's chances of obtaining permanent residency.

We help our clients to:

- ▶ Identify an occupation on the approved occupations list.
- ▶ Assess their total points via the Department's points-test calculator.
- ▶ Identify the areas in which they can strengthen their chances of claiming additional points.
- ▶ Provide a clear road map along with an indicative time frame.



General Skilled Visas

We provide assistance across the following categories:

- ▶ Skilled Independent Visa (subclass 189)
- ▶ Skilled Nominated Visa (subclass 190)
- ▶ Skilled Work Regional (Provisional) Visa(subclass 491)
- ▶ Permanent Residence (Skilled Regional) Visa (subclass 191)

The GSM program is a unique, points-tested system that is conducted over three stages:

- 1. Expression of Interest (EOI)**
- 2. Invitation to apply**
- 3. Submission of the visa application**

Of the four visa categories, only the subclass 491 is a transitional visa, allowing for permanent residency after a minimum period of 3 years. The application process can be complex and lengthy. Additionally, the legislation governing the process may be subject to frequent changes. Investing in a Registered Migration Agent to handle your visa application, removes the stress of managing an incredibly challenging, complicated and daunting process.



At VEVS, we take it upon ourselves to maintain the accuracy and completeness of your application while ensuring that you remain informed at every stage of the process.

Employer Sponsored Visas

The Employer Sponsored Visa program enables Australian businesses to seek and retain overseas talent.

As a business sponsor, it's important for you to understand the obligations attached to each visa subclass. Understanding the key differences between the visa streams will allow you to select the most appropriate solution to retain the right talent for your business.

An Employer Sponsored Visa requires:

- ▶ A valid standard business sponsorship
- ▶ An approved nomination application
- ▶ An approved skills assessment application (if required).
- ▶ Regional certification (if required).
- ▶ Approved English, health, character and age requirements.

We assist with the following visa categories:

- ▶ Temporary Skill Shortage (TSS), subclass 482 visa
- ▶ Employer Nomination Scheme, subclass 186 visa
- ▶ Regional Sponsored Migration Scheme, subclass 187 visa
- ▶ Skilled Employer Sponsored Regional (provisional), subclass 494 visa

In the fiscal year 2022-23, Australia experienced a substantial net annual gain in overseas migration, reaching an impressive figure of 518,000 people. While some families embarked on their Australian migration as a complete unit, many still have family members overseas.




Ten years on, VEVS is now one of the most reputable and respected agencies tailoring to clients from the subcontinents through to Southeast Asia.


